On-Campus Recruitment

Subject to the provisions of Section 1-210 (b)(11) of the Connecticut General Statutes, CREC high schools shall provide the same directory information and on-campus recruiting opportunities to representatives of the armed forces of the United States of America and state armed services as are offered to nonmilitary recruiters, recruiters for commercial concerns, and recruiters representing institutions of higher education.

CREC shall distribute annually to middle school students and require school counselors -to provide to middle and high school students and their parents/guardians information on the availability of (1) vocational, technical, technological, and postsecondary education and training at technical education and career schools, and (2) agricultural sciences and technology education at regional agricultural science and technology education centers. Such information shall be posted on the CREC website.

The CREC Council shall also provide full access for the recruitment of students by technical high schools, regional agricultural science and technology education centers, inter-district magnet schools, charter schools and inter-district student attendance programs, provided such recruitment is not for the purpose of interscholastic athletic competition. The CREC Council shall also post information about these school options on its website.

Military recruiters or institutions of higher learning shall have access to secondary school students' names, addresses, and telephone listings unless the parent of the student, or the student, if eighteen years of age or older, has submitted a written request to opt out of the disclosure of such information, in which case the information may not be released without the parent's (or the student's) prior written consent. CREC shall notify parents of the option to make such request and shall comply with any request received.

On-Campus Recruitment

The following regulations are established to ensure that on-campus recruitment of students is conducted in an orderly manner that is not disruptive to the high school program.

1. Organizations wishing to recruit at High School must make arrangements with the high school Principal or designee who will determine the schedule for the recruitment meeting.
2. Recruitment meetings will be limited to the same number for each organization for each academic year. The exact number will be determined by the Principal and will usually not exceed two recruitment meetings per year.
3. On-campus follow-up meetings with individual students will be permitted only upon the request of the student(s) and with the approval of the Principal or designee.
4. Scheduled visits by recruiters will be made known to the student body by school personnel.
5. The school administration reserves the right to deny a recruitment meeting or access request where the holding of such a meeting will materially and substantially interfere with the proper and orderly operation and discipline of the school; is likely to cause violence or disorder; or will constitute an invasion or violation of the rights of other students. Any person or entity denied access under this regulation shall have the right to request a review of the administrative decision by the Executive Director by filing an appropriate written request with the Executive Director.
