Ana Grace Academy of the Arts Elementary School: 2016 – 2017

Capital Projects Fund

Construction Division

CREC has identified a site at 34 Sequassen Street, Hartford, Connecticut for construction of the permanent location of the Ana Grace Academy of the Arts. CREC entered into a lease agreement, with an option to buy, with the owner and has completed its due diligence review of the site.

The Commissioner of Administrative Services requires CREC Council approval of sites that will be acquired for such use. We are seeking Council approval so that we can secure the State's approval of the site. This approval does not bind CREC to acquire the site. The purchase price, which was arrived at through an appraisal process in conformance with state regulations, is \$6,875,000.

RECOMMENDED ACTION: Approve the prospective purchase of the property located at 34 Sequassen Street, Hartford, Connecticut for the permanent location of the Ana Grace Academy of the Arts Elementary School.

Greater Hartford Academy of the Arts Middle School: 2016 – 2017 Capital Projects Fund Construction Division

CREC has identified a site at 15 Van Dyke Ave, Hartford, Connecticut for construction of the permanent location of the Greater Hartford Academy of the Arts Middle School. CREC entered into a lease agreement, with an option to buy, with the owner and has completed its due diligence review of the site.

The Commissioner of Administrative Services requires CREC Council approval of sites that will be acquired for such use. We are seeking Council approval so that we can secure the State's approval of the site. This approval does not bind CREC to acquire the site. The purchase price, which was arrived at through an appraisal process in conformance with state regulations, is \$5,500,000.

<u>RECOMMENDED ACTION</u>: Approve the prospective purchase of the property located at 15 Van Dyke Ave, Hartford, Connecticut for the permanent location of the Greater Hartford Academy of the Arts Middle School.

Ana Grace Academy of the Arts Elementary School
Capital Projects Fund #510
Construction Division

The Ana Grace Academy of the Arts Elementary School opened in leased space in in August of 2012. The school features an integrated learning environment for students, which combine a rigorous core curriculum enhanced by an art-themed focus. The arts curriculum provides students the opportunity to further explore vocal and instrumental music, visual art, dance, theatre, creative writing, and interdisciplinary arts. The 75,000 square foot school will serve 522 students in grades PK-5.

An application to construct a permanent school facility was approved by the State Department of Education in July 2013, in the amount of \$49,673,596. The architect, Amenta/Emma, has completed the final plans and the professional cost estimate for Phase 1.

The project will be reviewed in phases according to Department of Administrative Services' (DAS) guidelines, as follows:

- Phase 1 of 4 Sitework
- Phase 2 of 4 Building Construction
- Phase 3 of 4 Furniture, Fixtures and Equipment
- Phase 4 of 4 Playscape Equipment

In addition to these three phases, the project also has "soft costs", which include architectural design services, other professional services, site acquisition and contingency.

DAS must complete a plan review in order for CREC to bid Phase 1. As part of the process, DAS requires the Council's approval of the final plans and professional cost estimate for Phase 1. The remaining phases will come before Council for approval as the respective design is completed. The Council will have the opportunity to approve each phase. At this time, only Phase 1 requires Council approval.

<u>RECOMMENDED ACTION</u>: Approve the submission to DAS for the Phase 1 – Sitework (final plans and the professional cost estimate) for the Ana Grace Academy of the Arts Elementary School project.

Greater Hartford Academy of the Arts Middle School
Capital Projects Fund #511
Construction Division

The Greater Hartford Academy of the Arts Middle School opened in leased space at the Colt complex in Hartford, CT in August of 2012. The school provides students the opportunity to further explore vocal and instrumental music, visual art, dance, theatre, creative writing, digital storytelling, and interdisciplinary arts. The experiences children develop at this school will prepare them for more advanced level work at the Greater Hartford Academy of the Arts High School, which strives to prepare students for college and/or a professional career in the arts. The 127,500 square foot school will serve 660 students in grades 6-8.

An application to construct a permanent school facility was approved by the State Department of Education in July 2013, in the amount of \$74,614,104.

The architect, Antinozzi Associates, has completed the final plans and the professional cost estimate for Phase 1.

The project will be reviewed in phases according to Department of Administrative Services' (DAS) guidelines, as follows:

- Phase 1 of 3 Site Remediation and Temporary Shoring
- Phase 2 of 3 Building Construction
- Phase 3 of 3 Furniture, Fixtures and Equipment

In addition to these three phases, the project also has "soft costs", which include architectural design services, other professional services, site acquisition and contingency.

DAS must complete a plan review in order for CREC to bid Phase 1. As part of the process, DAS requires the Council's approval of the final plans and professional cost estimate for Phase 1. The remaining phases will come before Council for approval as the respective design is completed. The Council will have the opportunity to approve each phase. At this time, only Phase 1 requires Council approval.

Reading Recovery®: 2016 – 2017 (Revision)
General Fund
Division of Teaching and Learning

Reading Recovery® is an early intervention program for children most at risk of reading failure in the first grade.

The program has two professional development components:

> Reading Recovery® training for teachers and teacher leaders; and

> Ongoing professional development for trained Reading Recovery® teachers

Training of new Reading Recovery® teachers occurs at a Middletown facility serving the entire state while ongoing professional development for trained teachers is offered at selected districts.

The University of Connecticut, in partnership with the Ohio State University and 15 other universities, has received funds to support the training of new teachers whose districts commit to participating in the Reading Recovery® program. Local districts fund the continuing professional development for Reading Recovery® trained teachers.

This revision of \$1,200 is due to an increase in the funding for the program.
