A. Financial Report (Attachment F)

Jeff spoke about the Financial Report, specifically Column 3 of the last page. As of the last council meeting, there is \$418.6 million. As a result of the council's approval of today's consent agenda, the new total is \$401.5 million.

CREC is still owed \$2.6 million from ESTE for transportation, \$2.4 million from another entity also for transportation and \$2.5 million for transportation from last year.
