IX. LEGISLATIVE UPDATE

Our main goal is to work on having more money for magnet school sustainability and that there is a cap put in place for magnet school funding for the individual districts. At present, the State is not covering excess costs which is detrimental to individual district budgets.

With respect to special education, OPM has been given control of the budget and how money is spent. If a cap is kept in place, we can only charge up to the cap and no more.

The RESC's would fall under a rate scheduling model which means if a student needed special education services, there would be capped rates, and you cannot charge above that. If the rate needs to be increased, a request must be presented to the Office of Policy and Management. That means that individual RESC's no longer has control over what they can charge

April 27th is the deadline for the Appropriations Committee to report on their bills. There should be a budget within 2 weeks or so from the date of this meeting.

X. REPORTS

A. Financial Report (Attachment BB)

Carol Dewey gave the financial report. 3rd quarter highlights include revenue of \$317.7M which is an increase of \$7.7M. Currently revenue is over expenditures by about \$37.7M. That is more of a result of CREC's up front billing and/or grants that CREC has received. For the 4th quarter, we will see an increase in expense that will match up to the revenue amount.

XI. COUNCIL COMMENTS

Council voted on postponing the nominations for council positions for 2025-2027. Council is looking to fill the secretary/treasurer position and has no one currently. Motion was made by Leonard Lockhart and seconded by Joan Pina. The motion was passed unanimously.
