Meg Scata reported on the Finance and Audit Committee meeting held on September 10, 2025. The Head Start budget was approved for five years.

VI. EXECUTIVE DIRECTOR'S REPORT

Dr. Florio praised a smooth opening to the new school year and thanked Leadership for their contribution. He thanked Mason Thrall for overseeing Transportation and a smooth start as CREC transports over 9,100 students daily along 700 routes. Dr. Florio briefly spoke about the back to school event and Fallstaff, thanking Aura Alvarado and her team for making sure both events were successful.

Dr. Douglas spoke about her visits to schools on the first day and the slogan for this school year which is Defying Gravity.

Heather Tartaglia also reported a smooth start to the school year. CREC has submitted a grant application to renovate the kitchen at Wolcott to be able to provide meals to students including Head Start. The enrollment numbers for Head Start is strong this year.

Dr. Florio concluded by reminding the council that the 2025 annual CREC golf tournament is scheduled for October 6th. The golf tournament raises money for various scholarships awarded by CREC each year.

VII. COUNCIL CHAIR'S REPORT

Mr. Lockhart thank everyone for their efforts with respect to the back-to-school event and Fallstaff. He spoke warmly about being present at both and the important work done by CREC to educate Connecticut children. He expressed excitement for the new year and the importance of CREC's contribution to education.





VIII. DELIBERATED ACTION

A. Motion to appoint an Executive Director for the Capitol Region Education Council (CREC)

MOTION: Move that the CREC Council appoint Desi Nesmith as Executive Director of the Capitol Region Education Council effective February 1, 2026. Further, the CREC Council authorizes the Chairperson to negotiate and execute a contract with Desi Nesmith for the period of February 1, 2026 through January 30, 2029.

A Motion to approve the appointment of Desi Nesmith as CREC's Executive Director effective February 1, 2026 through January 30, 2029 was made by Lydia Tedone and seconded by Meg Scata. The vote was passed unanimously.

B. Email Council Vote on CREC Greater Hartford Academy of the Arts Renovation

By July 3, 2025, all approvals were received by email vote from the CREC Council in reference to the application for the renovation of the CREC Greater Hartford Academy of the Arts.

The resolutions approved include:

- Authorization to apply for the grant;
- Appointment of the existing School Building Committee as the building committee for this project;
- Approval of the local funding commitment; and
- Approval of the educational specifications.

These actions are recorded in accordance with the requirements of the Connecticut Department of Administrative Services (CT DAS) school construction application process. The approvals will be noted in the record and formally ratified at the next official meeting.

C. By July 24, 2025, all approvals were received by email vote from the CREC Council in reference to the application for a construction grant for renovations at the CREC Early Learning Center at Roger Wolcott (Windsor), specifically a reauthorization of the Educational Specifications highlighting the language requirements.
