**I. CALL TO ORDER and APPROVAL of MINUTES**

1/21/2026 Council Meeting called to order at 11:30 a.m.

**A. 11/19/2025 Council Meeting**

**MOTION:** A Motion to approve the November 19, 2025 minutes was made by Bobbie Granato and seconded by Miriam Underwood. Joan Pina abstained from voting as she was not at the meeting on November 19, 2025, but her name appeared as an attendee. Mr. Lockhart asked if there was any objection to approving the November minutes as presented. There were no objections, and the November minutes were approved by the council.

### **III. PRESENTATIONS to COUNCIL**

Dr. Sasha Douglas presented on CREC magnet schools. She spoke about the teaching and learning methods including accountability, academic performance index, and academic and personal growth. Overall, student absenteeism is down. CREC is working to make learning a group effort including the teachers, students, and their parents. What can parents do to contribute to positive academic growth? Are CREC schools safe, warm and inviting so that students feel nurtured and supported? CREC is also focusing on helping students transition to life after graduating from high school, whether that be higher education, a trade or entering the workforce. We want students to feel supported regardless of what decision they make with respect to their adult lives. Currently, 90% of CREC student have access to college courses. They are assisted with college applications and FAFSA processes. Ashley Mazzoli and Rich Serrano assist students with navigating the financial aid portion of their college applications.

CREC works with three core components – The Portrait of a Learner, High Quality Instruction and Centering Learners. We want our students not to be passive in their learning, but rather feel empowered, have more agency in their own learning and have a clear and purposeful path to learning.

Dr. Douglas invited several CREC students to the meeting to speak with respect to their experience in CREC schools and plans for their futures. Veronica Brunelle and Christina Browning, of Arts Academy (full day), talked about their efforts to help after the devastating storm in Jamaica several months ago. They coordinated with other CREC schools to gather supplies and necessities to help those in need after the storm.

Pehansa Samarakoon and Stella Mayan, of Aerospace Academy, spoke about their journeys testifying before legislators last year about the importance of magnet school funding, and their interest in political careers.

### **IV. COMMITTEE REPORTS**

Meg Scata gave the finance and audit committee report. This year's audit has been completed and the budget process for 2026-27 has already begun.

## **IX. LEGISLATIVE UPDATE**

Deb Borrero spoke about this year's legislative session, which is a short one, starting on February 4<sup>th</sup>. The governor will present his budget in the morning on that day. We are not only working towards more magnet school funding, but also sustainable funding. CREC is also looking for \$1.5M in funding for its Teacher Residency Program.

The CREC/HASA/CABE legislative breakfast will be held on February 10<sup>th</sup> at the State Capitol to outline key concerns and talking points for the legislative session.

Patrice McCarthy of CABE talked about funding, which is an ongoing issue, as a key topic for this year's legislative session, as well as trying to remove the cap on special education funding.
